Neighbouring Countries Econoic Development Cooperation Agency (NEDA) is an organization under the supervision of Neighbouring Countries Economic Development Cooperation Board (NEDB) whose operation is in the line with the Royal Decree on Rules and Procedures for Good Governance, B.E. 2546, Official Information Act, B.E. 2540 and Good Corporate Governance Policy of the Office of the Public Sector Development Commission. The meeting of NEDB is set to be held every month. NEDB considers matter related to core functions and supporting operations of NEDA both financial and nonfinancial matters.

NEDB is composed of one President and five board members who are the Permanent Secretary of the Ministry of Finance, the Permanent Secretary of the Ministry of Foreign Affairs, the Secretary General of the National Economic and Social Development Board, the Director General of the Fiscal Policy Office and the Director General of the Department of International Economic Affairs and three independent board members who supervise the works of NEDA.

Furthermore, NEDB appoined its members as a Chair of the subcommittee or members of various subcommittees to ensure that operations of NEDA is sound and comply with the good governance principles in line with NEDB's assignment

Results of NEDA in Fiscal Year 2014

In fiscal year 2014, NEDB introduced a policy and approved NEDA's annual action plan to carry out 10 work programs. NEDB focuses on extending financial and technical assistance to all 7 countries under the scope of work of NEDA. Such action plan will be carried out taking into consideration the policy to diversify NEDA's economic and social development assistance for to neighbouring countries into the areas other than transport sector such as water supply, urban development, public health and education. The important policy in the fiscal year 2014 is reducing dependence on government budget and collaborating with both domestic and foreign agencies. NEDB encourages NEDA to have a sustainable financial management to reduce its dependence on the government budget, by using accumulated funds of NEDA as well as raise funds from other sources to provide assistance to neighbouring countries and support operations of the organization. NEDA will work closely with domestic and foreign agencies to jointly support the economic and social development in the region. Additionally, NEDB gave importance on the proactive public relations to create an awareness of NEDA among other public and private agencies and general public in Thailand and neighbouring countries.

In accordance with to the policy and action plan stated above, NEDB has approved the budget of 1,483,427,000.00 baht, composed of 475,180,100.00 baht of government budget and 1,008,246,900.00 baht of NEDA's accumulated funds.


The operating results under the action plan of the fiscal year 2014 is 97.37% of all action plans, higher than the target of 95%. NEDA has entered into the Performance Commitment in the fiscal year 2014 with the Office of Public Sector Development Commission to specify the keys performance indicators, dividing into 4 dimensions with success equivalent to 4.9888 points or 99.77%. The operating results in accordance with the policy of NEDB can be concluded as follows:

The Cooperation in Economic and Social Development with Neighboring Countries

The key mission of NEDA is to cooperate with neighbouring countries in economic development by providing technical and financial assistance in a bid to maximize the economic potential and strength in the region. The cooperation focuses on the development of economic infrastructure and transport connectivity between Thailand and neighbouring countries as well as enhancing the quality of life of the people in the neighbouring countries with shared borders to be at the same level of other ASEAN countries.

The Guidelines for Receiving Assistance from NEDA

The financial assistance from NEDA is in the form of assistance between governments to government. The government from the country that needs assistance can submit a formal request to the Royal Thai Embassy, Ministry of Foreign Affairs of Thailand or directly to NEDA. NEDB will then consider the request. After NEDB's approval, NEDA will propose the matter to the Minister of Finance and to the Cabinet for consideration. 
The Methods of Receiving Financial Assistance from NEDA

The Overview of Operating Results of NEDA

Since its establishment until September 2014, NEDA has provided financial and technical assistance to four neighbouring countries (Cambodia, Lao PDR, Myanmar, Vietnam: CLMV) through 54 projects with the total amount of 12,466,820,000 baht.

The Results of Financial and Technical Assistance Operations in Fiscal Year 2014

The results of financial and technical assistance operations in the fiscal year 2014 can be concluded as follows:

1. Financial assistance

NEDB has approved 2 projects financial assistance projects to neighbouring countries with a total amount of 2.922 billion baht. However, this year, NEDA commitment for 7 financial assistance projects with a total budget of 1.241 billion baht for fiscal year 2014.

The Operating Results According to Key Performance Indicator (KPI) in fiscal year 2014

In the fiscal year 2014, NEDB has supervised NEDA to operate in accordance with Establishment of Neighbouring Countries Economic Development Cooperation Agency (Public Organization) Act, B.E. 2548 and related laws including other regulations. NEDB also encourages NEDA to continuously develop the human resources streamline and improve work process to ensure timeliness, flexibility and transparency and accountability; and fully utilize information technology in the operations.

According to the performance evaluation of the Office of the Public Sector Development Commission this year, NEDA under the supervision and suggestion of NEDB awere able to achieve good results based on the key performance indicators. The overall result was 4.9888 from 5.0000 points, or 99.77%. The details are in the following table.

Effectively and Sufficienly Financial Management for operation

In the fiscal year 2014, NEDB has approved the budget of 1,483,427,000.00 baht which consists of government budget of 475,180,100.00 baht and NEDA's saving accumulated funds of 1,008,246,900.00 baht. In 2014, NEDA has spent 1,437,322,752.59 baht, or 96.89% of the budget NEDB approved. The administration expenses was 100% carried out. In the fiscal year 2014, NEDA was able to save 14,157,790.24 baht on its operational expenditures.

In the fiscal year 2014, NEDA receives a return of 59,677,137.14 baht on its fund management. At the end of the fiscal year 2014, NEDA has a total accumulated funds of 1,180,522,085.11 baht with financial commitment of 628,174,808.12 baht.

Other Capital Management to Reduce Dependence on Government Budget

NEDA has spent its accumulated funds for its administration cost since the fiscal year 2013 to reduce its requirement on the government budget. The administration cost consists of personnel budget, operational budget and investment budget. Furthermore, NEDA is responsible for loan interest of the projects where NEDA borrows from the government specialized financial institutions. NEDA also spends its accumulated funds on research projects and knowledge sharing programs for officials of the neighbouring countries. The details are as follows:

Debt Collection and Management

1. Debt collection

NEDA has provided a financial assistance in the form of concessional loans to the neighbouring countries with a total disbursement of 7,084,866,586.32 baht. NEDA has collected 212,462,751.14 baht in debt principle and the current outstanding debt amounts is 6,872,403,835.18 baht. In the fiscal year 2014, NEDA has monitored and collected all debts in accordance with the contract. The debts are collected 32 times, with the total of 211,825,325 baht. This amount consists of debt principal of 138,491,245.45 baht and interest payment of 73,334,079.55 baht.

2. Debt management

NEDA has raised funds by borrowing from Export-Import Bank of Thailand and Government Savings Bank for on-lending. NEDA is responsible for the interest rate difference. In the fiscal year 2014, NEDA is responsible for paying the interest difference and loan interest of 66,925,249.61 baht.

Public Relations

NEDA has conducted public relations in many forms such as media interview, publication press tour to survey project areas as well as carrying out Corporate Social Responsibility (CSR) program. This year, NEDB has approved 4 million baht budget for public relations.

In the fiscal year 2014, NEDA has spent total of 3,038,671 baht on public relations. Public relations in media was carried out in newspaper, television, radio and NEDA's website. The website attracted 7,022 viewers. Additionally, NEDA organized a seminar with the press and private sector to publicize its projects in Trad Province. At the same time, NEDA also held a press tour, and CSR, in the area ob Koh Kong Sre Ambel Road Improvement Project (Route No. 48) in Cambodia Under the CSR program, NEDA renovated Tatai School and Tra Paing Roung School located in the mentioned area and donated school supplies and sport equipment to the schools on 25-27 September 2014.





Operations in Compliance with Good Governance

NEDB has set a policy on supervision and monitoring the organization to ensure that NEDA's Management carry out its operations to produce effective and acceptable results and achieve the objectives of NEDA in compliance with good governance, both terms of financial and operation management. NEDB will not intervene in the work of the management in a bid to create freedom and balance of policy abd administration.

According to the aforementioned policy of good governance, NEDA has allocated the budget for 2014 to put the policy of good governance into action. The activities can be concluded as follows:

- Organizing a seminar for executives and staff of NEDA to support and enhance work efficiency and to be in line with the good governance principles such as public works principles for executives, organizational performance management at the agencies and personnel levels, procurement and contract management, prescribing and declaring median price according to the regulations of the National Anti-Corruption Commission (NACC) and operation in e-GP system, etc.
- Supervising the operations of NEDA to be transparent and balanced by appointing internal and inspector from the Office of the Auditor General of Thailand to inspect the NEDA's works.
- Carrying out the procurement of NEDA is in accordance with the regulations of NACC regarding the criteria procedure, and declaration of the project account when a person or juristic person is a contract partner with state agency (B.E. 2554). NEDA has invited the representatives from potential external agencies to be members of the committee in the process of hiring, supervising and inspecting consultants. Furthermore, the procurement of the contract under the financial assistance must comply with the procurement regulations of the recipient countries. NEDA has sent its officials to monitor the bidding process of the neighbouring countries as well.
- Preparing information to be posted on NEDA's website for easy access of the public. This includes information about the NEDA's financial and technical assistance projects, project completion reports, and assessments of the financial assistance project 3-5 years after completion of projects.

Action plan of NEDA in fiscal year 2015

On 20 August 2014, NEDB has approved the three-year strategy of NEDA (from 2015 to 2017) to be used as a guideline for NEDA's operation during the fiscal year 2015 to 2017. In the fiscal year 2015, NEDA has started its three-year strategy (2015-2017) and operated under the 2015 action plan in line with the strategy that can be summarized as follows:

Vision: To be a leading organization in the region in economic and social development cooperation with the neighbouring countries in a bid to expand trade and investment opportunities between Thailand and neighbouring countries.

Mission:

- 1. Supporting government's policy regarding sustainable economic development cooperations with neighbouring countries by providing financial and technical assistance taking into consideration the mutual benefits on trade and investment with least dependence on the government budget.
- 2. Collaborating/coordinating closely with domestic and foreign public and private sector agencies by becoming a development partner to promote economic and social connectivity in the region.

Key objectives:

- 1. Cooperating with neighbouring countries on economic and social development by providing financial and technical assistance
- 2. Collaborating/coordinating with domestic and foreign public and private sector agencies in economic and social development cooperation with neighbouring countries
- 3. Developing knowledge on project management which was carried out with neighbouring countries and encouraging the participation of private sector.
- 4. Promoting organizational management efficiency by developing personnel, system and technology to enhance service to the international standard.

Strategy:

First strategy: Cooperation with domestic and foreign government and private sector agencies on economic and social development in the region

Developing a strategy and cooperative plan with neighbouring countries regarding financial and technical assistance and cooperating with government agencies and private sector in Thailand and neighbouring countries and other developmental organizations

Second strategy: Enhancing the financial and technical cooperation with neighbouring countries to attain international standard and quality

Reviewing criteria, regulations and workflow regarding financial and technical assistance in a bid to to enhance efficiency of the cooperation and meet international standard as well as developing an action plan to diversify financial and technical assistance in more dimensions. Cooperating with private sector and conducting a more proactive public relations.

Third strategy: Financial management to sustain operations

Managing funds to be adequate for NEDA's operations by conducting a ten-year cash flow estimation, and developing debt payment plan and fund mobilization plan for operations in the fiscal year 2015. Moreover, reviewing of financial assistance terms and studying investment innovations for NEDA will be required to reduce dependence on the government budget.

Fourth strategy: Developing good governance and learning organization

Developing a working system by enhancing knowledge body of NEDA; organizing academic seminars and lunch talks; and reviewing and developing manuals as well as strengthening databases and data dissemination system in a bid to become a learning organization. Developing a system to enhance work efficiency of staff, hand-in-hand with good governance.

According to the said plan, NEDB has approved the budget of 2015 to NEDA for the amount of 1,666,036,047.03 baht for fiscal year 2015 for NEDA which consists of NEDA's accumulated funds of 909,963,747.03 baht, loan from financial institutions of 100,000,000.00 baht and government budget of 656,072,300.00 baht.
