INVITATION FOR PREQUALIFICATION

1. The Government of the Lao PDR has received a loan from the Royal Thai Government (RTG) towards the cost for The Improvement of National Road No.12 Section Thakhek-Na Phao Project. The eligible rules and procedures of MPWT will govern the prequalification and the bidding process.
2. In order to develop the project, the Ministry of Public Works and Transport (MPWT) (hereinafter referred to as the "Employer") will engage a suitably qualified Thai contractor firm to carry out the civil works for The Improvement of National Road No.12 Section Thakhek-Na Phao Project. The Contractor firm may associate with Lao contractor firms but the total share proportion of Lao contractor shall be less than 50% of the cost of the construction.
