 - Experience in large contract. 20 Points

8. Minimum score to pass the EOI is 70 points All firms submitted the EOI will be advised the results of their EOI
9. It is expected that DOR will only invite the shortlisted Consultants to submit the technical and financing proposal (RFP) on or about 25 September 2024 for Consulting Services of the Project.
